Non-Operating Individual (NOI), Resumption of Enforcement of Merchant Mariner Credential (MMC) Requirements

On January 1, 2025, the U.S. Coast Guard's statutory authority to enforce the requirement for a NOI to possess an MMC resumed. During the last 4 years, the Coast Guard was mandated by law to not enforce this requirement on these individuals. The authority to enforce this requirement was suspended by Congress from January 1, 2021, through December 31, 2024. See Pub. L. 116-283, div. G, title LVXXXIII [LXXXIII], §8313(a), (b), Jan. 1, 2021, 134 Stat. 4697, 4698, as amended by Pub. L. 117-263, div. K, title CXV, §11516, Dec. 23, 2022, 136 Stat. 4141.

During the period of non-enforcement, the Coast Guard could not enforce the MMC requirement(s) on marine firefighters, spill response personnel, salvage personnel, and commercial divers and diving support personnel who were engaged or employed on board any vessel for the sole purpose of carrying out spill response activities, salvage, marine firefighting, or commercial diving business or functions. Where an Offshore Supply Vessel (OSV), industrial vessel, or other similarly engaged vessel was specifically concerned, in addition to any of the individuals mentioned above, the Coast Guard could not enforce the MMC requirement(s) on individuals who were engaged or employed on board to:

- Support or execute the industrial business or function of such a vessel.
- Perform tasks not traditionally performed by the crew, such as
 - o Conducting surveys or investigations for brief periods
 - Assessing crew competence
 - Conducting vessel trials
 - o Providing extraordinary security resources.
- Perform warranty maintenance on equipment, maintenance on equipment not owned by the vessel owner, or maintenance beyond the crew's capability.
