With the environmental and economic importance of the Great Lakes region, Congress mandated that the U.S. Coast Guard establish the Great Lakes Oil Spill Center of Expertise (GLCOE). The GLCOE, unique within the Coast Guard, advances freshwater and icy water oil spill response capabilities through innovative research, equipment acquisition, and responder training. Join us in this mission by exploring our research funding opportunities.

Legislative Mandate – Section 807 of the Frank LoBiondo Coast Guard Authorization Act of 2018 (Pub. L. 115-282).

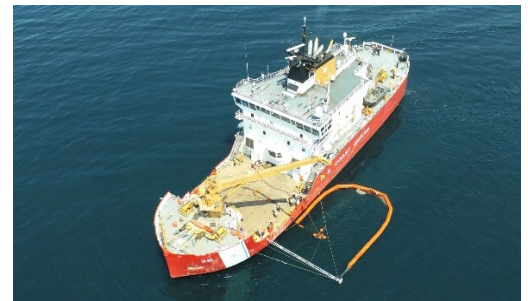
